APPENDIX A-ORGANIZATIONAL, PROCEDURAL RULES App. A, § II

- q. Adjournment.
- (8) Citizens' agenda. Citizens desiring to do so may be heard on any matter after the calendar of events. Each will be allowed not more than three minutes to address county council. Once the public comments are received as called for in this section, and except for such comments, no further public comment will be accepted except for scheduled public hearings or as specifically authorized by county council by formal vote. Meetings of county council are based upon the representative form of government and are regulated by parliamentary procedures, and are not town meetings. Accordingly, the citizens' agenda is for the receipt of citizen opinions, comments and input, and is not a time for debate, question-and-answer, or dialogue. Any citizen who is retained by a person, group or organization for the purpose of promoting or opposing any matter before the county council for compensation shall disclose the person(s), group(s) or organization(s) the retained citizen represents at the time of appearing before county council, or will not be allowed to speak or present to county council.
