

In compliance with the Freedom of Information Act, agendas for the following meeting were delivered to all members of Council, County Attorney Richard Ness, Lower Savannah COG, The Bamberg Leader, The Times and Democrat, Southern Carolina Regional Alliance, Bamberg County Library, Bamberg County Website and Bamberg County Courthouse Annex.

In light of the COVID-19 pandemic, Bamberg County Council met 6:00 p.m., January 6, 2025 in Council Chambers with limited seating for the public alongside live streaming of the meeting provided for public view. **Present:** Chairman Evert Comer, Jr., Councilwomen Sharon Hammond and Michelle Martin, Councilmen Spencer Donaldson, Kenneth Ahlin and Larry Haynes. **Absent:** Dr. Jonathan Goodman, II. **Others Present:** Joey R. Bamberg County Council meeting was called to order by Chairman Evert Comer, Jr., at 6:00 p.m. Invocation was rendered by Councilman Larry Haynes, followed with the pledge of allegiance led by Councilwoman Sharon Hammond.

On motion by Councilwoman Hammond, seconded by Councilman Haynes, the minutes from the December 9, 2024 meeting were approved with necessary corrections should there be any.

On motion by Councilwoman Hammond, seconded by Councilman Haynes, council approved the agenda as presented.

Swearing in of re-elected member Councilman Spencer Donaldson (District #4), was performed by Chief Magistrate Judge Craig Threatt and during this time the bible was held by Councilman Donaldson's wife Ms. Denise Donaldson. Due to Dr. Jonathan Goodman, II (District #5), was unable to attend the scheduled meeting for his swearing in, Judge Threatt administered the oath of office to him earlier during day and the bible was held by his wife Dr. Cheri Goodman.

Newly elected members Kenneth Ahlin (District #1) and Michelle Martin (District #7), were sworn in by South Carolina Attorney General Alan Wilson. Councilman Ahlin's daughter held the bible for his ceremony. Councilwoman Martin had Councilman Ahlin to hold the bible during her oath of office. After the ceremony, SC Attorney General Wilson said he was honored to swear in the two newest council members and to serve the citizens of Bamberg County.

On motion by Councilman Donaldson, seconded by Councilman Haynes, council followed the County's Rules and Procedures that the changing of the gavel from outgoing Chairman Evert Comer, Jr., be passed to Councilwoman Sharon Hammond (District #2) for the year 2025. After accepting the gavel and the chairmanship, Chairwoman Hammond presented outgoing Chairman Comer with a plaque of appreciation on behalf of Bamberg County as a whole. Councilman Comer was praised for his accomplishments while serving in the capacity as chairman. Mr. Comer stated he was encouraged by the resilient nature of Bamberg County citizens and he was honored to serve as Council Chairman and he looks forward to continuing his service in District 6.
