MINUTES OF BAMBERG COUNTY COUNCIL VIRTUAL MEETING

In compliance with the Freedom of Information Act, agendas for the following meeting were mailed to all members of Council, County Attorney Richard Ness, Lower Savannah COG, *The Bamberg Leader*, *The Times and Democrat*, SouthernCarolina Regional Alliance, Bamberg County Library, Bamberg County Website, Bamberg County Courthouse Annex and a copy posted on the bulletin board in the main hallway of the County Courthouse.

June 30, 2021

In light of the COVID-19 pandemic, Bamberg County Council met 6:00 p.m., June 30, 2021 in several locations within the Bamberg County Courthouse Annex and some participated by way of teleconference. The public joined the meeting by various means of technology. **Present:** Chairman Larry Haynes, Councilwoman Sharon Hammond, Councilmen Evert Comer, Jr., Spencer Donaldson, Phil Myers, Jr., Clint Carter and Dr. Jonathan Goodman, II. **Others Present:** Joey R. Preston, T.M. Thomas, Richard Ness, Adam Ness, Alice Johnson, Gina Smith, Chip Maier, Dionne Gleaton, Mark Tyler, Dianne Black, Summer Johnson, Sue Weiler Greenberg, Kay Maxwell, Farrell Pulaski, Jannie Johnson, Candace Fralix, Sarah G. Noel, Walt Inabinet, Bill Johnson, Ruthie Brown, Michael Chassereau and two additional callers.

Bamberg County Council Virtual meeting was called to order by Chairman Larry Haynes at 6:00 p.m. Invocation was rendered by Councilman Evert Comer, Jr., followed with the pledge of allegiance led by Councilman Spencer Donaldson.

On motion by Councilman Comer, seconded by Councilwoman Hammond, council approved the agenda as submitted.

-Order of Business-

At this time, Chairman Haynes addressed the public hearing section by reading the following for public comments: An ordinance to adopt the operating and capital budgets of Bamberg County for the fiscal year beginning July 1, 2021 and ending June 30, 2022, and to make appropriations for such Bamberg County Budgets for county ordinary purposes for which the county may levy a tax; to provide for the levy of taxes on all taxable personal and real estate properties in Bamberg County of such county ordinary purposes, including sufficient tax to pay the principal and interest on outstanding indebtedness of Bamberg County maturing during said fiscal year; and to provide for other matters relating to Bamberg County and Bamberg County budgetary matters. Chairman Haynes asked if there were any comments from the public. No comments from the public had been received. Administrator Preston read into the record, a letter received from SouthernCarolina Alliance President Danny Black, concerning the passing of the Bamberg County FY 2021-2022 budget. Letters from Mayor Nancy Foster – Bamberg; Mayor Gerald Wright – Denmark and Mayor Wilma Edmonds – Govan had been previously presented for considerationduring the budget process. (Letters attached to the Minutes).

On motion by Councilwoman Hammond, seconded by Councilman Comer, council approved the second round of recreation grants for seven programs that applied after the initial target date. Programs to receive funds are: Bamberg Youth Baseball (6and under - \$700); Bamberg Youth Baseball (7-8 - \$1,000); Bamberg Youth Baseball (9-10 - \$700); Bamberg Youth Baseball (11-12 - \$700); Bamberg Youth Softball (7-9 - \$700); Bamberg Youth Softball (10-12 - \$700); Bamberg Youth Baseball (13-14 - \$1,000).

Total funds paid out to the recreation program for this fiscal year was \$11,209.50. Administrator Preston said the balance (\$2,790.50) will be carried forward into the next fiscal year to be reallocated in the next budget.

Chairman Haynes read: An ordinance to adopt the operating and capital budgets of Bamberg County for the fiscal year beginning July 1, 2021 and ending June 30, 2022, and to make appropriations for such Bamberg County Budgets for county ordinary purposes for which the county may levy a tax; to provide for the levy of taxes on all taxable personal and real estate properties in Bamberg County of such county ordinary purposes, including sufficient tax to pay the principal and interest on outstanding indebtedness of Bamberg County maturing during said fiscal year; and to provide for other matters relating to Bamberg

County and Bamberg County budgetary matters - Council, third reading. On motion by Councilman Donaldson, seconded by Councilman Myers, council approved to enter in discussion of the FY 2021-2022 budget ordinance totaling \$27.5 million. Councilman Carter said that he had been trying to make a motion to continue with last year's budget and that no new employees be added. Also, calling for no new raises except for employees who didn't receive a raise last year. Administrator Preston answered that the agenda would have had to be amended at the beginning of the meeting in order to be included. Councilman Carter and Councilwoman Hammond raised several concerns such as: not receiving additional documentation regarding budget, itemized list of personnel without salaries grouped together, etc. Referencing the budget, Controller Gina Smith conveyed the fact that there are other revenue sources in the budget that we know are coming. Bamberg County has already received some of the funds in May from the Biden-Harris American Rescue Plan funds. Also, we will receive the other half of those funds in May of 2022. Some of those funds are included in this budget that's presented. Councilwoman Hammond asked that council be County Attorney Richard Ness informed Council that they had to included in how those funds are spent. pass the budget to be in compliance with state law. At the direction of Attorney Richard Ness, he had Attorney Adam Ness read a letter from Cydney Milling, the state's assistant attorney general. Ms. Milling declared in her letter that state law requires the county to adopt a budget before the start of the fiscal year July 1 and if the county failed to do so, it may be prohibited from expending county funds until it adopts a budget. Administrator Preston reiterated that the counties that have passed a resolution in the past had a problem that they did not have a balanced budget. We have a balanced budget before the council. The budget has received two readings and if anyone is doing it, according to legal analysis, it's illegal. After additional discussion, Chairman Haynes called for the vote. Those voting in favor of the budget were: Councilmen Comer – District 6; Donaldson – District 4; Goodman – District 5 and Chairman Haynes – District 3. Those voting not in favor of the budget were: Councilwoman Hammond – District 2; Councilmen Myers – District 1 and Carter – District 7. The budget passed with no tax increase.

At this time Chairman Haynes called for a motion to adjournment. On motion by Councilman Comer, seconded by Councilwoman Hammond the meeting adjourned at 7:05 p.m.

I am trying to understand why you all are not passing the Bamberg County Budget. County Council has had all year to understand, or gain knowledge about the County operations and expenditures. Go see your Administrator! Please find out what is going on!

Not passing a budget affects more than just the County. It affects the municipalities as well. We share many cost saving operations for the City and the County. To name a few...agreement with Sheriff's Department, jail facilities, Fire Department, tax collection, magistrate, building inspections, grant opportunities, etc. Not passing a County budget could have dire consequences to our citizens.

A budget documents expenses and income. A budget is created so that your expenses do not exceed your income. The county has to live within the adopted budget.

During the development of the budget, information from the current year and previous years are used; current revenues and expenditure, cash flow, debt service commitments, financial reports and capital plans. The County has to comply with Department of Local Government Finance (DLGF) regulations and meet State Board of Accounts standards.

The County is audited every year...Bamberg County has received clean, unmodified audits which is the best opinion a County can receive.

Without a comprehensive understanding of governmental accounting and an in-depth knowledge of the county, the annual budget process can be confusing and complex.

Each department of county government has a line-item budget to track every dollar spent on personnel, supplies, operating and equipment costs. The County has an operating budget and a capital budget. An operating budget is a plan of current spending and the means to pay for it (taxes, fees, grants, etc.). A capital budget contains long-term spending objectives and acquisition of assets along with the means to pay for them including, borrowing and/or bonding.

The annual operating budget serves as the County's most significant policy document and operating plan. As County officials, I understand that you must be sure that the decisions you make financially are going to continue to help the County be sustainable for many years to come. But get with your Administrator, all year long, before budget time to understand what is going on.

Please do all you can to make this budget work and pass it. The City of Bamberg and Bamberg County share many services; saving the County and the City many tax dollars.


God bless you for all you do. It is not easy being an elected official, but we have been elected and must do our very best to make our County and cities the best they can be.
